Woodhaven is not responsible for moving any furniture or removal or reinstallation of window treatments

All delivered and/or installed materials, goods and products shall remain the property of Woodhaven until the full amounts due are paid.

This contract shall be governed by the laws of the State of New Jersey without regard to its conflict of laws principle. The parties agree to the jurisdiction of the courts of the State of New Jersey, Ocean County.
